## CoVID-19 updates from our partners at AUSTRADE

### VISA:

Students unable to return to Australia to continue their studies may have their study deferred. This will not affect their visa status.

Temporary relaxation of working hours – **until 1 May 2020**, international students working in major supermarkets, aged care and nursing are able to extend their working hours from the maximum 40 hours a fortnight.

Students offshore and studying online with an Australian education provider do not need a visa. Education providers can issue a new Confirmation of Enrolment (CoE) and enrol students to study online.

### Student Health Care and OSHC:

If an international student is showing symptoms of COVID-19, they should phone the National Coronavirus Helpline on 1800 020 080 for information and advice.

If translating or interpreting services are required, call 131 450.

## Calling all Internationally Qualified Midwives and RN's IQNM's OBA is HERE!

### Outcomes-Based Assessment (OBA) what is it?

The Nursing and Midwifery Board of Australia (NMBA) has announced a new assessment model for the registration of internationally qualified nurses and midwives in the country. The board will also introduce an Outcomes-Based Assessment replacing the current bridging program for nurses not having "substantially equivalent" qualifications.

As an internationally qualified nurse and midwife (IQNM) seeking registration in Australia, it is important that you have a good understanding of what it is like to work within the Australian healthcare system. It can be quite different to healthcare systems in other countries.

The Nursing and Midwifery Board of Australia (NMBA) has developed an orientation program to introduce IQNMs to a range of concepts relating to the Australian healthcare context. The aim is to keep the public safe by supporting IQNMs who register with the NMBA to prepare for the environment in which they will be working.

The NMBA's orientation program has two parts:

- Orientation Part 1 - online learning which introduces the Australian healthcare context. Part 1 must be completed as part of the IQNM assessment process, after completing the Self-check (see Steps after Self-check (assessment stages) for more information)
- Orientation Part 2 - online learning giving a more in-depth orientation to the Australian healthcare context. For all IQNMs who register with the NMBA, it is a requirement of registration to complete Part 2 within 12 months of becoming registered (see Registration application outcomes for more information).
- Employers of registered IQNMs are expected to provide local orientation through an induction program.
