I am writing today to advise you that a modified 2020 Fly Now Pay Later program called "LIL Scholarship", (**Low Interest Loan scholarship**), will start again this year. Under the Pre COVID19 issues we have successfully funded two students to date so this will be a third year, although slightly different, we will be offering this scholarship, and I hope more places can be filled.

Some of you may be familiar with the process but for those who are not here it is! **Firstly, the requirements to be considered as a candidate.**

1. BSN Nurse, Board Passer not necessary but will be positively recognized in the selection process. Sorry no Under Grade
2. No break in your employment from the day you received your BSN certificate to June 30, 2020. Some exceptions may apply e.g. having a child.
3. Under 35 as of June 30, 2020
4. Current Filipino Passport with no visa refusals if travelled
5. NBI Clearance will be required to be accepted
6. Current Health certificate with no signs of TB will be required to be accepted
7. Co Borrower will be required (Details to be given to chosen candidates)
8. Family support needs to be shown as this is a long process to become an Australian citizen!
9. Dedication and commitment, this is a 4-year program!

Of course, **conditions apply** but please email us if you want to know more.

### VISA News.

According to a recent article on SBS World News the Visa process done in countries outside of Australia is taking longer than those who actually apply "On Shore". Our experience has been in the Philippines, the time taken is getting longer for SC500 student visa's so we are considering from now on to send all our students to Australia on the SC600 visitor visa that allows for you to stay for 3 months and complete your practicum. Before you actually leave for Australia, we will gather together all of your requirements for the SC500 Student Work Visa and once you have successfully landed, we will do your application.



## AUSTRALIA NEWS

To Day, July 7<sup>th</sup> I attended a Webinar given by AUSTRALIA.

In summary

1. If you are in Australia and working in the Health Industry on your SC500 Visa, you are no longer restricted to 40 hours work per fortnight but check with your job provider and your college.
2. For those who are already undertaking our OLT courses you will need to put this fact and details in your GTE when applying for a new SC500 visa. This will give you a more positive result to be accepted. You can do this when in Australia or before you go. We will assist you with this.
3. No previously granted SC500 will be extended due to the fact even though you have one granted you cannot go to Australia. You will need to do a new one and fees, at this stage, will not be waived BUT they are considering this.
4. If you are currently in Australia and need help go to the Australian Red Cross for assistance, they have just been given a large amount of money to assist stranded student sin financial trouble.
